### **Application of Business Law**

In Indonesia, the government has established legal provisions such as the Civil Code of Law, which can also be called Burgerlijk Wetboek, which is a legal product that contains provisions governing civil not public relationships between business actors/ civilian. In addition to BW, other legal products are also provided that directly or indirectly regulate the actions and behavior of entrepreneurs, such as issuing regulations in the fields of anti-monopoly, protection, consumers, employment, limited liability companies, cooperatives, banking, tax insurance, transportation, and others.(Hermanto, 2018)

In addition to written legal products such as BW and the regulations above, the principles or principles of decency, custom, and public interest are also standards and

guidelines for business actors. The condition of consumers who have suffered a lot requires increased efforts to protect them so that their rights can be enforced. (Hermanto, 2018)

However, on the other hand, this protection must also protect the existence of producers who are essential to the country's economy. Therefore, legislation is needed that can protect both parties. The problem of consumer protection will never run out and will always be the subject of discussion in the community. As long as there are still many consumers who are harmed, the problem will never be resolved. Therefore, the issue of consumer protection needs to be considered. Consumer rights that business actors ignore need to be carefully observed. (Maharani & Darya Dzikra, 2021)

The purpose of discussing enforcing business law evenly in Indonesia is to know Indonesia's ability to carry out procedures and establish regulations for all companies or someone who wants to run a business without any fraud and parties who escape the business law that has been stipulated in the law. Economic Democracy is a form of economic activity of a country. In an economic democracy, the government regulates all-natural resources owned to be used for the common interest of its citizens. Economic Democracy is also the basis for policy formulation in the domestic economy to strengthen democratic governance and be a regulator and directing the course of national economic activities. (Dewantara, 2014)

Because the purpose of economic democracy is for the interests and prosperity of the people, the land, water, and natural resources contained therein will be managed and controlled by the state through State-Owned Enterprises (BUMN). For example, natural resources such as Petroleum are owned by a country, a form of economic democracy; a state-owned company usually manages the resources. In Indonesia, the state company that manages Petroleum is PT Pertamina Persero. PT Pertamina Persero also has several subsidiaries that manage other natural resources owned by Indonesia, such as Liquefied Natural Gas (LNG) and Liquefied Petroleum Gas (LPG).

The activities of Indonesian Economic Democracy, seen from time to time, still show the difficulty of Economic Democracy for the common people, because most of the economic activities still dominated by the owners of capital (the bourgeoisie) and leaves little room for the common people to obtain rich natural resources owned. (Dewantara, 2014)

This is coupled with the government's position as a policymaker and economic actor, which has not been able to optimally utilize and allocate economic resources equitably to all economic actors on the micro, small and medium scale. It often happens when the government seems to succumb to the pressure and demands of the owners of capital, resulting in policies that are only in favor of a few people, which will have adverse effects. (Dewantara, 2014)

**Business Sustainability**

Talking about the industrial sector is closely related to a business. In a business, we will be able to see from two different perspectives: a business point of view (organizationally) and aspects outside the business that affect the business. Sometimes the government limits policies that make it difficult for companies to move, making it difficult for companies to innovate. 
