While the understanding of monopoly for the community is the existence of one producer or seller who has monopoly power if the producer or seller has the ability to control the market for the goods or services he trades, so basically what is meant by monopoly. # **Environmental Damage**

Otto Soemarwoto defines environmental damage as an environment that has been polluted or damaged and there are the following elements: if a substance or other elements such as gas, light and energy are mixed into a resource and the environment, then it disrupts the environmental ecosystem itself. (Suryati, 2010)

Environmental damage causes changes that occur directly and indirectly, such as changes in physical properties or biological species that have an impact on reducing the role of the environment or damage to the environment and do not support or cannot be utilized for sustainable development. (Priantoko et al., 2021)

Environmental damage takes many forms, including: water pollution, soil pollution and air pollution. All forms of pollution are very detrimental to the environment and also humans because of the reduced supply of needs produced by the environment. Then from environmental damage will also cause other social problems, such as disease and natural disasters. (Priantoko et al., 2021)


