Occupational Safety

Work Environment

Work Environment is something that is around employees so that it affects someone to get a sense of security, comfort, and satisfaction in doing and completing the work that has been given (Anam, 2018). 5. Effect of Occupational Safety on Occupational Health

Will protect himself from the dangers of the impact of chemicals or particles of production materials. Based on the literature review and the discussion above, the researcher determines the conceptual framework as follows:




Figure 1: Conceptual Framework
